III. RMS RFP Update - Laura Wohl

Overview: Ms. Wohl briefed the Board on the status of the RMS replacement process. Three RFP responses were received. The Steering Committee reviewed the responses and are moving all three vendors forward. Demonstrations are scheduled for January and February. Demos will consist of demonstrations by the vendors and also a "live" lab where staff can try the software for themselves. The Steering Committee is developing a schedule for the demos that is broken down by role, eg: Patrol Officers, Detectives, Evidence staff, Records staff, Jail staff, etc. As soon as the schedule is finalized, Department's Systems Administrators (SAs) will be responsible for identifying who needs to be in which part of the demos for their agency. The demos will be held at LPD or the Thurston County Emergency Center, depending on availability.

Ms. Wohl noted that the primary outstanding task for the project is hiring the Project Manager. Lacey, who will me managing the position, reported that the position still has not been approved by their City Manager. Chief Almada has a meeting soon with the interim City Manager and hopes to have an update following that meeting.
