### **I. Review and Approval of December Meeting Minutes – Chief Weiks**

### **II. Election of Board Chair for 2023**

**Overview:** Each year, the Board Chair must be elected by the Board per the intergovernmental agreement that established LERMS.

Chief Weiks stated that he is willing to be the Board Chair for another year, but would also be happy to pass it to another Board Member if one is interested. No other Board members expressed an interest.

**Action Item:** Nominate and elect a Board Chair for 2023.

Chief Almada nominated Chief Weiks to be the Board Chair for 2023. No further nominations were made and nominations were closed. Motion to elect Chief Weiks Board Chair.

### **III. Appointment of Lead Agency - Chief Weiks**

**Overview:** Every three years, the Lead Agency, which acts as the LERMS Business Agent, must be appointed by the Board per the intergovernmental agreement that established LERMS. The Lead Agency was last determined in 2020 and 2022 was the final year of the 3 year appointment. Olympia was appointed Lead Agency in 2020, although Tumwater filled the role for the last year of the term.

Tumwater agreed to continue to fill the roll of Lead Agency for the next 3 years, upon appointment.

V. **RMS RFP Update – Laura Wohl**

**Overview:** Status of the new RMS project.

Ms. Wohl updated the Board on the progress of the new RMS project. Demos of the systems for which we received RFPs have begun. Users from all agencies attended the CentralSquare demo on January 11-12. The participants for the RMS felt that it represents a significant improvement over the current CentralSquare RMS. TCSO staff felt the RMS product was much better than their current system. The Steering Committee met and discussed the staff comments and their own assessment of the system. There is concern about whether the JMS is functional to the level needed by TCSO. Several questions arose about a variety of functionality that we will need to have answered by the vendor and would want to see in action during a site visit. Next vendor demo will be EIS on January 25-26, and then 365Labs on February 1-2.

Chief Almada told the Board that the Project Manager position for the RMS/JMS project has been approved by the Lacey City Manager. The Lacey HR Department will begin the recruiting and hiring process. The HR Department has a large workload right now and it will be added to their schedule.
