RESOLUTION NO. R2022-015

A RESOLUTION of the City Council of the City of Tumwater, Washington, authorizing certain partnerships with charitable organizations for the purpose of providing a supportive social fabric to the community, aiding the poor and infirm, building employee morale, and accomplishing City strategic priorities and goals.

WHEREAS, the City Council has acknowledged the City as a vision, mission and beliefs based organization; and

WHEREAS, the City desires to authorize use of resources to partner with nonprofit charitable organizations for the purpose of providing a supportive social fabric to the community, aiding the poor and infirm, building employee morale, and accomplishing City strategic priorities and goals; and

WHEREAS, the City has on-going adopted partnerships with certain nonprofit organizations that directly benefit City operations, goals, and objectives;

WHEREAS, the City Council finds these relationships and activities support fundamental purposes of government; and

WHEREAS, the City desires to provide City employees guidance on when joint fundraising campaigns and donation drives are acceptable.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TUMWATER AS FOLLOWS:

<u>Section 1</u>. The following charities have a special relationship with the City because of overlapping interests and direct partnerships in alignment with City goals.

<u>Section 2</u>. <u>Ratification</u>. Any act consistent with the authority and prior to the effective date of this Resolution is hereby ratified and affirmed.

The invalidity of any clause, sentence, paragraph, subdivision, section, or portion of this Resolution or the invalidity of the application thereof to any person or circumstance, shall not affect the validity of the remainder of the Resolution, or the validity of its application to other persons or circumstances.
