Suppression Report

Where should fire extinguishers be located?

Fire extinguishers that are placed correctly can be accessed more quickly to help control a fire until the Fire Department arrives. Fire extinguishers are not intended to be a substitute for evacuating the building quickly and safely.

Two factors for placing extinguishers are that they should be accessible and visible. Extinguishers should be placed where they are readily accessible in the event of a fire, which typically includes normal paths of travel. If visual obstructions cannot be avoided then arrows. lights, or signs are needed to help indicate where a fire extinguisher is located. Travel distance to the nearest extinguisher can't be more than 75 feet in most commercial office settings. If an extinguisher weighs more than 40 pounds the extinguisher can't be more than 3.5 feet from the top of the extinguisher to the ground, and no more than 4 inches from the bottom of the extinguisher to the ground. Extinguishers under 40 pounds can't be more than 5 feet from the top of the extinguisher to the ground, and no more than 4 inches from the bottom of the extinguisher to the ground. Requirements for fire extinguisher size and spacing based on hazard levels are defined by the National Fire Protection Association.
